HIPAA Reminders

Given the significant public attention on the healthcare system nationwide, we wanted to take this opportunity to remind everyone of the strict HIPAA rules and University Hospital policies regarding the protection of our patients' privacy. The existing patient privacy requirements that we already observe continue to apply:

1. Ensure that you only access, use, or disclose Protected Health Information as necessary to treat patients or perform your job.
2. Only discuss Protected Health Information for treatment purposes. Take reasonable steps to ensure that these conversations are in private.
3. Ensure that you do not share or discuss the identity of anyone presenting for treatment, for any non-treatment purposes, including in discussion with family or friends.
